Medium Report

The following report is a summary of my visions and messages received about your case. I had no knowledge of the specifics of your case prior to arriving. Any suggestions I may give for resolution to your paranormal activity will be included in this report and are merely suggestions.

We arrived at the library at approximately 8:00 PM. The team went into the library while I stayed outside. I focused on connecting to the house and the property. Earlier that day, I received a vision of a jump rope and jacks and equated those items to a young girl. As I was driving to the library, I received a message of three names. Two of them the same, Mary, and the other was Anna. I was also given the message that there were two wives connected to the library. I thought it would be weird that a man would marry two women with the same name. Later, I found out that the two women named Mary were Mr. Smith's mother and one of his wives. His other wife's name was Anna.

I was sitting on the bench that was in the yard underneath the large tree in the yard. I knew the library used to be the home of Guilford Smith. While I was sitting there, I could hear the laughter of children, but I was told by my guide that this was a childless home. I was also told that the first wife died from childbirth or complications from childbirth. I am not sure if that can be verified.

Also, while I was sitting on the bench, I felt as if something was missing. I looked around and saw that there was used to be a structure where I was sitting. I could see the past coming forward and people interacting with this structure. I was able to see quaint garden parties with women in long gowns and big hats and the men congregating in the corner of the property behind the structure avoiding the women.

I was told there would be a room in the house that belonged to Guilford, and I would be able to gather information from the house in that room. I was told to sit in the rocking chair. When I went into the library, I did come across a room that faced the factory across the room and could also see the front porch and any prospective visitors. There was a rocking chair in that room.

I sat in the chair and began connecting with the house and Guilford. Guilford was a hardworking and determined businessman. I also was given the impression that he was a strict man. He was firm and a ran his life and his factory in a very regimented style. The energy I was gathering about Guilford Smith was residual or an imprint of him from when he lived and owned the home.

I came across multiple spirits while I was touring the library. There was a room to the right of the entrance toward the back of the house where an African American woman was working. Her energy was strong and extremely prevalent, and I knew she would communicate with us later.

I toured the upstairs and when walking into the bedroom, I felt the loss of life even stronger than before. I asked, "Was this the room you died in?" I noticed a cradle in the room. It was Guilford's, but it was intended to be the child that did not live long enough to use it.

I walked by the librarian's office which also had the entrance to the attic in it. I said to myself that we would need to go up there. I knew this was a childless house, but I was still noticing a young girl. Her name began with the letter "E." I thought at the time it was either Emily or Eliza.

The most compelling spirit to come forward for me was the mistress of the house, the second Mrs. Guilford Smith. At one point during the investigation, I smelled a floral fragrance. The rest of my team also experienced smelling the fragrance. I asked if this was her perfume.

The other location where I encountered a spirit was in the attic. A young girl was there. I asked her why she was there, but she didn't give me an answer. I just assumed this is where she played. This young girl was connected to the family, but not as a relative.

I encountered a strong-willed African American woman in the main area of the library. It was mostly her energy rather than her being present. This woman took no grief from anyone. She may not have been the mistress of the house, but you *knew* who ran the house. This woman was a stout woman, taller than most women at the time. She ran the house with an iron fist. She would even correct her employers. Mr. Smith appreciated her style, but I can say with certainty Mrs. Smith did not.

This library was a delight to investigate. I know I was able to gather information psychically and I am sure we were able to capture evidence, at least audio evidence. I would love the opportunity to return to the library to go further in our discoveries, especially the African American woman and the young girl.

I am not surprised the library is an active location. Rest assured, benign spirits inhabit the library, most of them residual. The spirits that do interact are harmless but curious. If at any time the spirits frighten the library staff, they should just acknowledge the spirits and move on with their daily tasks.
